1. 因應集團營運之需求,為追求永續經營及發展,期能採取更靈活的發展策略,調整內部營運架構及規劃未來營運發展方向,本公司間接透過UMT HOLDINGS (SAMOA) LIMITED (下稱「UMT」)全資(100%)持有之子公司UMT Holdings (Cay man) Limited (係依英屬開曼群島法律組織設立;下稱「合併子公司」)擬與本公司直接及間接持有合計55.59%之孫公司Radiation Technology, Inc. 芮特科技股份有限公司(下稱「芮特科技」)進行反式三角合併(下稱「本合併案」),自本合併案生效之時點起,由合併子公司作為消滅公司,芮特科技作為存續公司,成為UMT全資(100%)持有之子公司並承擔及取得合併子公司所有承諾、資產及負債;本合併案之合併契約暨合併計畫稿本,請參閱本手冊第40至123頁,附件八。

- 2. 依據企業併購法第6條規定,本公司董事會決議併購事項前,應由審計委員會就併購事項計畫與交易之公平性、合理性進行審議,並將審議結果提報董事會及股東會。審計委員會進行前揭事項之審議時,應委請獨立專家就換股比例或配發股東之現金或其他財產之合理性提供意見。
- 3. 本合併案業經審計委員會於113年3月5日決議委請國富浩華聯合會計師事務所邱繼盛會計師作為獨立專家,就合併對價提供合理性意見。除合併契約暨合併計畫另有規定外,本合併案將由UMT按每一股芮特科技普通股股份新台幣53.8元支付合併對價,獨立專家出具之合理性意見,請參閱本手冊第124至140頁,附件九。
- 4. 本合併案之合併基準日暫訂為113年10月18日,並擬授權UMT 視公司營運狀況或主管機關要求,全權處理或修正有關本合併 案之具體時間。
- 5. 擬授權UMT辦理本合併案之相關事務,包括但不限於協商、調整、簽署、執行及交付相關文件及合約(包括但不限於合併契約暨合併計畫)、聲明書、承諾及其他文件,以及相關必要事務

之處理。有關本合併案之送件具體時間,亦授權UMT視公司營 運狀況或主管機關要求全權處理或修正之。

- 6. 本案業經113年3月13日審計委員會審議通過,並經同日董事會 決議通過後,提請113年股東常會同意。
- 7. 陳淑敏董事長目前持有芮特科技0.14%之股份、郭俊良董事目前持有芮特科技1.13%之股份及吳東義董事目前擔任芮特科技之董事,鑑於(1)本合併案之公平性、合理性業已依規定取得獨立專家出具之合理性意見書,並經審計委員會進行審議,已可確保本合併案對價之公平及合理性;且(2)芮特科技私有化有助於集團追求永續經營及發展所需,能採取更靈活的發展策略,調整內部營運架構及規劃未來營運發展方向,故前述董事如參與本公司董事會對於本合併案討論及表決,尚無有害於公司利益之虞,且董事長「陳淑敏」、董事「郭俊良」及董事「吳東義」於本公司董事會討論時贊成本合併案。

#### 112 年度營業結果

摘要整理 112 年度所達成的具體成果如下:

- (一)順利擴增低軌道衛星通訊客戶群並通過衛星酬載元件之認證與量產交貨。
- (二) 導入精密機台與充實高規格檢驗設備使產品規格再升級。
- (三)完成東南亞設廠規劃,有助於增進客戶間的合作廣度、承接訂單增長的需求。

#### 茲就 112 年度之營運相關數據彙整說明如下:

#### (一) 營業計畫實施成果

昇達科 112 年度合併營收 1,585,208 仟元,較 111 年度 1,837,665 仟元,減少 13.74%。合併稅後純益為 241,327 仟元,較 111 年度 324,570 仟元,減少 25.65%。

## (四)研究發展狀況(合併財務報表)

本公司 112 年度研究發展支出主要重點在於因應新一代通訊效率與品質需求,而持續進行相關衛星通訊產品、5G 與物聯網等相關產品的設計開發與軟硬體投資,同時配合客戶與市場需求,開發新一代的產品應用為主。相關研究發展支出整理如下表:

## 113 年度營業計畫概要

113 年度仍將延續過去所累積的成果,除繼續深耕既有客戶、並持續開發新客戶外,同時也將著重於下列營運要項的執行,冀望得以建立永續經營的深厚根基:

#### (一) 經營方針及重要產銷政策

1. 擴大東南亞產能規模並與客戶建立長期的穩定合作:

為因應低軌道衛星通訊產業前景所帶起廣大商機的產能需求,以及滿足客戶在地緣性競爭所要求的風險分散,今年將是落實先前規劃擴展東南亞產能的執行年度,這方面的規劃也將善用東南亞國家的租稅優惠,達到更好的稅務效益,而未來所涵蓋的產品也會逐年擴增,將子公司的合適產品也具有產能擴增的彈性與成本優化的效果,使集團中的相關企業同樣受惠於此項規劃,而能藉由競爭力的再次提升,建立與客戶端更長遠的合作優勢,以推升公司整體的營運績效。

2. 擴增低軌道衛星通訊產業需求之產品廣度以持續提升營收規模:

隨著低軌道衛星通訊客戶群的逐年擴增,以及相關產品所開發的成果亦漸豐碩,因此接下來更可善用這樣的根基,來擴大與各個客戶的合作廣度,並可再由產業新參與者的需求,提供成熟運用經驗的產品協助客戶縮短開發摸索期,快速獲得客戶所倚賴並成為長期發展所需的合作夥伴,進而使公司在低軌道衛星通訊應用領域扮演關鍵角色,並在營收規模上獲得持續性的增長動能、持續提升營收規模。

3. 善用產能優化製造成本以提升獲利率:

預期在產能擴增過程中,善用規模經濟與製程優化可以帶來更具 競爭力的生產成本,再加上去年度已經在製程自動化與良率管控上獲 得不錯的成效,今年度在加以延伸當可以使更多元的產品受惠,且相 關成果還可複製到不同的製造基地比照運用,讓成本優化效益加以擴 增,以達到提升公司整體獲利率的更佳效果。

#### (二)預期銷售數量及依據

以客觀條件進行觀察,銷售數量係依據市場需求與發展趨勢、客戶營運狀況及公司目前接單情形而定。而無線通信的智慧生活願景及 5G 搭配衛星通訊在物聯網時代的應用所趨,產業前景仍可以高度樂觀來預期,尤其低軌道衛星通訊應用將為整體產業發展帶動起高度的成長,對提供低軌道衛星通訊關鍵元件的昇達科而言,當可繼續保持競爭優勢與強化客戶網絡。

#### 外部競爭環境、法規環境及總體經營環境之影響

整體而言,在外部競爭環境、法規環境與總體經營環境上雖然每年多少都有些許不同,但在同樣面對全球地緣性競爭加劇、國際原物料持續上揚的經營環境,對於客戶基礎穩固與獲利穩健的公司有競爭力上的優勢,而昇達科正具備這樣的基礎,因此對於公司營運前景仍持正向看待。

#### 未來發展策略

隨著衛星製造技術的持續提升,特別是低軌道衛星通訊的創新發展,創造 出不同於傳統高軌道衛星的應用價值,加上衛星發射成本的快速下降,如共乘、 中大型衛星載具等創新服務,持續促進全球衛星發射數量的大幅擴增。以2022 年全球運行中的7,316 顆衛星來看,商業通訊為應用佔比已達到63%,主要來自物聯網、機聯網等應用商機,伴隨全球運行中衛星的快速增加,也會帶動衛星終端設備的發展,讓使用者在移動中使用衛星訊號,不同衛星間訊號快速地切換,達到無縫接軌的通訊韌性。由這樣的發展趨勢來看,足見低軌道衛星通訊將帶起一波長期且廣大的商機,這也可以由近幾年在美國華盛頓特區所舉與領展會,今年度所展示的規模與參與人數也是歷年之最,所展示的多款衛星通訊不住,在展會期間並與多家業者進行深入的交流,預期對於日後拓展商機有相當助益。而因應全球地緣性的競爭環境,昇達科亦已有完備的因應規劃,可以滿足客戶地緣性風險的分散需求並兼顧產能擴增之需,相信對於增進與實的合作廣度可以產生加乘效果。自本公司設立以來一直秉持著『穩健踏實、以滿足客戶地緣性風險的分散需求並兼顧產能擴增之需,相信對於增進與客戶、於應商等合作夥伴一同努力,以期實踐昇達科成為『無線通訊產業最值得仰賴的元件供應商』之使命,並為股東創造價值、提供員工可發揮潛能的舞台,善盡企業社會責任並繼續發揮企業價值而努力。

最後,謹代表公司全體員工感謝所有股東對昇達科的支持與鼓勵,並致上 最誠摯的謝意。

## 查核意見

昇達科技股份有限公司民國 112 年及 111 年 12 月 31 日之個體資產負債表,暨民國 112 年及 111 年 1 月 1 日至 12 月 31 日之個體綜合損益表、個體權益變動表、個體現金流量表以及個體財務報表附註(包括重大會計政策彙總),業經本會計師查核竣事。

依本會計師之意見,上開個體財務報表在所有重大方面係依照證券發行人財務報告編製準則編製,足以允當表達昇達科技股份有限公司民國 112 年及 111 年 12 月 31 日之個體財務狀況,暨民國 112 年及 111 年 1 月 1 日至 12 月 31 日之個體財務績效及個體現金流量。

#### 查核意見之基礎

本會計師係依照會計師受託查核簽證財務報表規則及審計準則執行查核工作。本會計師於該等準則下之責任將於會計師查核個體財務報表之責任段進一步說明。本會計師所隸屬事務所受獨立性規範之人員已依會計師職業道德規範,與昇達科技股份有限公司保持超然獨立,並履行該規範之其他責任。本會計師相信已取得足夠及適切之查核證據,以作為表示查核意見之基礎。

#### 關鍵查核事項

關鍵查核事項係指依本會計師之專業判斷,對昇達科技股份有限公司民國 112 年度個體財務報表之查核最為重要之事項。該等事項已於查核個體財務報表整體及形成查核意見之過程中予以因應,本會計師並不對該等事項單獨表示意見。

兹對昇達科技股份有限公司民國 112 年度個體財務報表之關鍵查核事項 敘明如下:

## 特定客戶銷貨收入認列真實性

昇達科技股份有限公司民國 112 年度之營業收入較去年同期下降,惟來自特定客戶之營業收入較去年同期具顯著成長,且該等客戶交易金額對整體營業收入係屬重大,因此將對該等特定客戶銷貨收入認列真實性考量為關鍵查核事項。

與銷貨收入認列相關會計政策暨攸關揭露資訊,請參閱個體財務報表附註四。

本會計師對於上開所述之特定客戶銷貨收入認列之真實性已執行主要查 核程序如下:

- 瞭解及抽樣測試銷貨交易收入認列之真實性相關之主要內部控制制度設計與執行之有效性。
- 針對特定客戶抽核原始訂單、出貨單及發票等原始憑證,覆核相關交易 表單是否齊備及檢視公司入帳及收款對象與金額與各表單是否相符。
- 3. 檢視特定客戶期後銷貨退回及折讓之發生情形,並發函確認年底應收帳款是否有異常情事。

#### 管理階層與治理單位對財務報表之責任

本會計師從與治理單位溝通之事項中,決定對昇達科技股份有限公司民國 112 年度個體財務報表查核之關鍵查核事項。本會計師於查核報告中敘明該等事項,除非法令不允許公開揭露特定事項,或在極罕見情況下,本會計師決定不於查核報告中溝通特定事項,因可合理預期此溝通所產生之負面影響大於所增進之公眾利益。

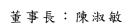

- 瞭解及抽樣測試銷貨交易收入認列之真實性相關之主要內部控制制度設計與執行之有效性。
- 針對特定客戶抽核原始訂單、出貨單及發票等原始憑證,覆核相關交易 表單是否齊備及檢視公司入帳及收款對象與金額與各表單是否相符。
- 3. 檢視特定客戶期後銷貨退回及折讓之發生情形,並發函確認年底應收帳款是否有異常情事。

#### 其他事項

昇達公司業已編製民國 112 及 111 年度之個體財務報表,並經本會計師 出具無保留意見之查核報告在案,備供參考。

#### 管理階層與治理單位對合併財務報表之責任

管理階層之責任係依照證券發行人財務報告編製準則及經金融監督管理 委員會認可並發布生效之國際財務報導準則、國際會計準則、解釋及解釋公 告編製允當表達之合併財務報表,且維持與合併財務報表編製有關之必要內 部控制,以確保合併財務報表未存有導因於舞弊或錯誤之重大不實表達。

於編製合併財務報表時,管理階層之責任亦包括評估昇達公司及其子公司繼續經營之能力、相關事項之揭露,以及繼續經營會計基礎之採用,除非管理階層意圖清算昇達公司及其子公司或停止營業,或除清算或停業外別無實際可行之其他方案。

昇達公司及其子公司之治理單位(含審計委員會)負有監督財務報導流程之責任。

## 會計師查核合併財務報表之責任

本會計師查核合併財務報表之目的,係對合併財務報表整體是否存有導因於舞弊或錯誤之重大不實表達取得合理確信,並出具查核報告。合理確信係高度確信,惟依照審計準則執行之查核工作無法保證必能偵出合併財務報表存有之重大不實表達。不實表達可能導因於舞弊或錯誤。如不實表達之個別金額或彙總數可合理預期將影響合併財務報表使用者所作之經濟決策,則被認為具有重大性。

本會計師依照審計準則查核時,運用專業判斷及專業懷疑。本會計師亦執行下列工作:

- 辨認並評估合併財務報表導因於舞弊或錯誤之重大不實表達風險;對所評估之風險設計及執行適當之因應對策;並取得足夠及適切之查核證據以作為查核意見之基礎。因舞弊可能涉及共謀、偽造、故意遺漏、不實聲明或踰越內部控制,故未偵出導因於舞弊之重大不實表達之風險高於導因於錯誤者。
- 對與查核攸關之內部控制取得必要之瞭解,以設計當時情況下適當之查 核程序,惟其目的非對昇達公司及其子公司內部控制之有效性表示意見。
- 3. 評估管理階層所採用會計政策之適當性,及其所作會計估計與相關揭露 之合理性。

6. 對於昇達公司及其子公司內組成個體之財務資訊取得足夠及適切之查核 證據,以對合併財務報表表示意見。本會計師負責集團查核案件之指導、 監督及執行,並負責形成昇達公司及其子公司查核意見。

本會計師與治理單位溝通之事項,包括所規劃之查核範圍及時間,以及 重大查核發現(包括於查核過程中所辨認之內部控制顯著缺失)。

本會計師亦向治理單位提供本會計師所隸屬事務所受獨立性規範之人員 已遵循會計師職業道德規範中有關獨立性之聲明,並與治理單位溝通所有可 能被認為會影響會計師獨立性之關係及其他事項(包括相關防護措施)。

本會計師從與治理單位溝通之事項中,決定對昇達公司及其子公司民國 112年度合併財務報表查核之關鍵查核事項。本會計師於查核報告中敘明該等 事項,除非法令不允許公開揭露特定事項,或在極罕見情況下,本會計師決 定不於查核報告中溝通特定事項,因可合理預期此溝通所產生之負面影響大 於所增進之公眾利益。

WHEREAS, certain Directors of the Company has declared and explained the nature and essential contents of its personal interest in the Merger and the reason of approval or disapproval of the resolution in connection with the transaction contemplated hereunder, and the Board of Directors of the Company unanimously (a) determined that the Merger and this Agreement are advisable and in the best interests of the Company and its shareholders, (b) approved this Agreement, the Merger, and the other actions contemplated under this Agreement, and (c) recommended that the shareholders of the Company vote to approve this Agreement, the Merger and such other actions as contemplated hereunder.

### Article 1 Definitions and Interpretation 定義與解釋

1.1. Unless otherwise defined, capitalized terms used in this Agreement shall have the meanings set forth in Schedule 1.

1.2. References in this Agreement to sections and schedules are to sections in and schedules to this Agreement (unless the context otherwise requires). The recitals and schedules to this Agreement shall be deemed to form part of this Agreement.

#### Article 2 The Merger 合併

2.1. Structure of the Merger. At the Effective Time and subject to and upon the terms and conditions of this Agreement and the applicable provisions of the Cayman Companies Act, (i) Merger Sub shall merge with and into the Company, and as a result of the Merger, Merger Sub shall cease to exist and will be struck off the Register of Companies in the Cayman Islands, (ii) the Company shall continue as a surviving company (as defined under the Cayman Companies Act, the "Surviving Company")

under the Merger and become a wholly-owned subsidiary of Parent.

Unless this Agreement is earlier terminated pursuant to the provisions of Article 7 of this Agreement, and subject to the satisfaction or waiver of the conditions set forth in Article 4.1, Article 4.2, and Article 4.3 of this Agreement, the consummation of the Merger (the "Closing") shall take place at No. 1, Gongjian Rd., Qidu Dist., Keelung City, R.O.C. on October 18, 2024, or at such other time, date and place as Parent and the Company may mutually agree in writing. The date on which the Closing actually takes place is referred to as the "Closing Date". At the Closing, Merger Sub and the Company shall execute a plan of merger (the "Plan of Merger") (in substantially the form attached hereto as Exhibit A) and such parties shall file the Plan of Merger (together with the other documents that may be required under the Cayman Companies Act) with the Registrar of Companies of the Cayman Islands in accordance with the Cayman Companies Act. The Merger shall become effective on the date on which the Plan of Merger is registered by the Registrar of Companies in the Cayman Islands (or such later date as may be specified in the Plan of Merger as mutually

agreed between Parent and the Company), being not more than the 90th day after the date of such registration) in accordance with the Cayman Companies Act (the "**Effective Time**").

Subject to the requirement of Article 3.4, the Per-Share Merger Consideration shall be adjusted appropriately to reflect the effect of any share sub-division, share consolidation, distribution of cash dividend, share dividend (including any dividend or other distribution of securities convertible into Company Ordinary Shares), reorganization, recapitalization, reclassification, combination, share exchange or other similar change with respect to the Company Ordinary Shares effectuated after the date hereof and prior to the Effective Time, so as to provide the holders of Company Ordinary Shares with the same economic effect as contemplated by this Agreement prior to such event and as so adjusted shall, from and after the date of such event, be the Per-Share Merger Consideration.

Each holder of such Company Ordinary Share as reflected in the Company's Register of Members immediately prior to the Closing shall cease to have any right with respect thereto, except the right to receive the Per-Share Merger Consideration payment as described in this Agreement in relation to the Company Ordinary Shares described in Article 2.5.1(i) or the right to receive a payment in relation to the Dissenting Shares described in Article 2.6, and the payment thereunder shall be deemed to have been in full satisfaction of all rights pertaining to the Company Ordinary Shares.

Such ordinary shares of the Surviving Company shall be the only issued and outstanding share capital of the Surviving Company, which shall be reflected in the register of members of the Surviving Company.

Notwithstanding any provision of this Agreement to the contrary and to the extent available under Cayman Companies Act, any Company Ordinary Shares that are issued and outstanding immediately prior to the Effective Time and that are held by shareholders who shall have validly exercised and not effectively withdrawn or lost their rights to dissent

from the Merger in accordance with Section 238 of the Cayman Companies Act or the Company's Memorandum and Articles of Association (the "Articles") (the "Dissenting Shares", holders of Dissenting Shares being referred to as "Dissenting Shareholders") shall be cancelled and the Dissenting Shareholders shall not be entitled to receive the Per-Share Merger Consideration with respect to such Dissenting Shares held by them immediately prior to the Effective Time. Instead, and without prejudice to any right they may have under the Cayman Companies Act, such Dissenting Shareholders shall be entitled to receive only the payment of the fair value of such Dissenting Shares held by them in accordance with the provisions of such Section 238 of the Cayman Companies Act or the Company's Articles. To the extent any such Dissenting Shareholders have failed to perfect or who effectively have withdrawn or lost their rights to dissent from the Merger under Section 238 of the Cayman Companies Act or the Company's Articles, such Dissenting Shareholders shall immediately thereupon (i) not be deemed to be Dissenting Shares and (ii) be deemed to have been cancelled and converted into, and to have become exchanged for, as of the later of the Effective Time or the time of such withdrawal or loss, the right to receive the Per Share Merger Consideration, without any interest thereon, pursuant to Article 2.5.1(i) unless otherwise excluded pursuant to Article 2.5.1(ii) or 2.5.1(iii). Parent (or a designee of Parent) shall promptly deposit or cause to be deposited with the Paying Agent (and the Paying Agent shall be directed to promptly thereafter transmit to the Taiwan Depositary & Clearing Corporation) any additional funds necessary to pay in full the aggregate Per Share Merger Consideration so due and payable to such shareholders who have failed to perfect or who shall have effectively withdrawn or lost such right to seek payment of the value of such Shares.

Notwithstanding the foregoing, the Surviving Company shall promptly deposit or cause to be deposited with the Paying Agent such amount as may be necessary so as to cause the Paying Agent to pay such Dissenting Shareholder, in an amount equivalent to the Per-Share Merger Consideration for each such Dissenting Share, in advance of the final and binding determination of such Dissenting Shares' fair value. The Surviving Company's obligation to pay the fair value to such Dissenting Shareholder for his or her Dissenting Shares shall be automatically reduced in the corresponding amount of such payment. In the event that any written notices of objection to the Merger are served by any shareholders of the Company pursuant to Section 238(2) of the Cayman Companies Act, the Company shall serve written notice of the authorisation of this Agreement and the Plan of Merger on such Shareholders pursuant to Section 238(4) of the Cayman Companies Act within twenty (20) days of the approval of the Merger by shareholders of the Company at the shareholders' meeting.

#### 2.7. Payment.

# NINTH AMENDED AND RESTATED MEMORANDUM OF ASSOCIATION OF

- 1. The name of the Company is Radiation Technology, Inc. 芮特科技股份有限公司.
- 2. The Registered Office shall be at the offices of Portcullis (Cayman) Ltd, The Grand Pavilion Commercial Centre, Oleander Way, 802 West Bay Road, P.O. Box 32052, Grand Cayman KY1-1208, Cayman Islands.
- 3. Subject to the following provisions of this Memorandum, the objects for which the Company is established are unrestricted and the Company shall have full power and authority to carry out any object not prohibited by Act.
- 4. Subject to the following provisions of this Memorandum, the Company shall have and be capable of exercising all the functions of a natural person of full capacity irrespective of any question of corporate benefit, as provided by Section 27(2) of The Companies Act.
- 5. Nothing in this Memorandum shall permit the Company to carry on a business for which a licence is required under the Acts of the Cayman Islands unless duly licensed.
- 6. If the Company is an exempted company, it shall not trade in the Cayman Islands with any person, firm or corporation except in furtherance of the business of the Company carried on outside the Cayman Islands; provided that nothing in this clause shall be construed as to prevent the Company effecting and concluding contracts in the Cayman Islands, and exercising in the Cayman Islands all of its powers necessary for the carrying on of its business outside the Cayman Islands.
- 7. The liability of each member is limited to the amount from time to time unpaid on such member's shares.
- 8. The share capital of the Company is NT\$1,000,000,000.00 divided into 100,000,000 ordinary shares of a nominal or par value of NT\$10.00 each.
- 9. The end of the Company's financial year shall fall on the December 31st of each year.

We, the undersigned, are desirous of being formed into a Company pursuant to this Memorandum of Association and the Companies Act, and we hereby agree to take the numbers of shares set opposite our respective names below.

#### INTERPRETATION

- 1. The Regulations contained or incorporated in Table A of the First Schedule of the Companies Act shall not apply to this Company.

  - (iii) words importing persons only shall include companies, partnerships, trusts, associations or bodies of persons whether incorporated or not;
  - (iv) a notice provided for herein shall be in writing unless otherwise specified and all reference herein to "in writing" and "written" shall include printing,

lithography, photography and other modes of representing or reproducing words in permanent visible form including in the form of an Electronic Record:

- (v) in these Articles, Sections 8 and 19 of the Electronic Transactions Act shall not apply; and
- (vi) "may" shall be construed as permissive and "shall" shall be construed as imperative.
- (d) Heading used herein are intended for convenience only and shall not affect the construction of these Articles.

#### **SHARES**

- 3. (a) Subject to the provisions of the Act, if any, in that behalf in the Memorandum of Association, and without prejudice to any special rights previously conferred on the holders of existing Shares, any Share may be issued with such preferred, deferred, or other special rights, or such restrictions, whether in regard to dividend, voting, return of Share capital or otherwise, as the Company may from time to time by Special Resolution determine, and subject to the provisions of section 37 of the Act, any Share may, with the sanction of a Special Resolution, be issued on the terms that it is, or at the option of the Company or the holder is liable, to be redeemed.
  - (b) If at any time the share capital is divided into different classes of Shares, the rights attached to any class (unless otherwise provided by the terms of issue of the Shares of that class) may be varied with the consent in writing of the holders of three-fourths of the issued Shares of that class or with the sanction of a resolution passed by not less than three-fourths of such holders of the Shares of that class as may be present in person or by proxy at a separate general meeting of the holders of the Shares of that class. To every such separate general meeting, the provisions of these Articles relating to general meetings shall mutatis mutandis apply, but so that the necessary quorum shall be any one or more persons holding or representing by proxy not less than one-third of the issued Shares of the class and that any holder of Shares of the class present in person or by proxy may demand a poll.
- 4. (a) Every person whose name is entered as a Member in the Register of Members shall be entitled, without payment, to a certificate of the Company specifying the Share or Shares held by him and the amount paid up thereon, provided that in respect of a Share or Shares held jointly by several persons, the Company shall not be bound to issue more than one certificate, and delivery of a certificate for a Share to one of several joint holders shall be sufficient delivery to all.
  - (b) If a Share certificate is defaced, lost or destroyed it may be renewed on payment of such fee, if any, and on such terms, if any, as to evidence and indemnity, as the Directors think fit.
- 5. Except as required by Act, no person shall be recognised by the Company as holding any Share upon any trust, and the Company shall not be bound by or be compelled in any way to recognise (even when having notice thereof) any equitable, contingent, future or partial interest in any Share (except only as by these Articles or by Act otherwise provided or under an order of a court of competent jurisdiction) or any other rights in respect of any Share except an absolute right to the entirety thereof in the registered holder, but the Company may in accordance with the Act issue fractions of Shares.

6. The Shares shall be at the disposal of the Directors, and they may (subject to the provisions of the Act) allot, grant options over, or otherwise dispose of them to such persons, on such terms and conditions, and at such times as they think fit, but so that no Share shall be issued at a discount, except in accordance with the provisions of the Act.

#### TREASURY SHARES

- 7. Shares that the Company purchases, redeems or acquires (by way of surrender or otherwise) may, at the option of the Company, be cancelled immediately or held as Treasury Shares in accordance with the Act. In the event that the Directors do not specify that the relevant Shares are to be held as Treasury Shares, such Shares shall be cancelled.
- 8. No dividend may be declared or paid, and no other distribution (whether in cash or otherwise) of the Company's assets (including any distribution of assets to members on a winding up) may be declared or paid in respect of a Treasury Share.
- 9. The Company shall be entered in the Register of Members as the holder of the Treasury Shares provided that:
  - (a) the Company shall not be treated as a member for any purpose and shall not exercise any right in respect of the Treasury Shares, and any purported exercise of such a right shall be void;
  - (b) a Treasury Share shall not be voted, directly or indirectly, at any meeting of the Company and shall not be counted in determining the total number of issued shares at any given time, whether for the purposes of these Articles or the Act, save that an allotment of Shares as fully paid bonus shares in respect of a Treasury Share is permitted and Shares allotted as fully paid bonus shares in respect of a treasury share shall be treated as Treasury Shares.
- 10. Treasury Shares may be disposed of by the Company on such terms and conditions as determined by the Directors.

#### LIEN

- 11. The Company shall have a first and paramount lien on every Share (not being a fully paid Share) for all moneys (whether presently payable or not) called or payable at a fixed time in respect of that Share, and the Company shall also have a lien on all Shares (other than fully paid-up Shares) standing registered in the name of a single person for all moneys presently payable by him or his estate to the Company; but the Directors may at any time declare any Share to be wholly or in part exempt from the provisions of this Article. The Company's lien, if any, on a Share shall extend to all dividends payable thereon.
- 12. The Company may sell, in such manner as the Directors think fit, any Shares on which the Company has a lien, but no sale shall be made unless some sum in respect of which the lien exists is presently payable nor until the expiration of fourteen days after a notice in writing, stating and demanding payment of such part of the amount in respect of which the lien exists as is presently payable, has been given to the registered holder for the time being of the Share, or the persons entitled thereto by reason of his death or bankruptcy.
- 13. For giving effect to any such sale, the Directors may authorise some person to transfer the Shares sold to the purchaser thereof. The purchaser shall be registered as the holder of the Shares comprised in any such transfer and he shall not be bound to see to the application of the purchase money, nor shall his title to the Shares be affected by any irregularity or invalidity in the proceedings in reference to the sale.

14. The proceeds of the sale shall be received by the Company and applied in payment of such part of the amount in respect of which the lien exists as is presently payable, and the residue shall (subject to a like lien for sums not presently payable as existed upon the Shares prior to the sale) be paid to the person entitled to the Shares at the date of the sale.

#### CALLS ON SHARES

- 15. The Directors may from time to time make calls upon the Members in respect of any moneys unpaid on their Shares provided that no call shall be payable earlier than one month from the last call; and each Member shall (subject to receiving at least fourteen days' notice specifying the time or times of payment) pay to the Company at the time or times so specified the amount called on his Shares.
- 16. The joint holders of a Share shall be jointly and severally liable to pay calls in respect thereof.
- 17. If a sum called in respect of a Share is not paid before or on the day appointed for payment thereof, the person from whom the sum is due shall pay interest upon the sum at the rate of six per cent per annum from the day appointed for the payment thereof to the time of the actual payment, but the Directors shall be at liberty to waive payment of that interest wholly or in part.
- 18. The provisions of these Articles as to the liability of joint holders and as to payment of interest shall apply in the case of non-payment of any sum which, by the terms of issue of a Share, becomes payable at a fixed time, whether on account of the amount of the Share, or by way of premium, as if the same had become payable by virtue of a call duly made and notified.
- 19. The Directors may make arrangements on the issue of Shares for a difference between the holders in the amount of calls to be paid and in the times of payment.
- 20. The Directors may, if they think fit, receive from any Member willing to advance the same all or any part of the moneys uncalled and unpaid upon any Shares held by him; and upon all or any of the moneys so advanced may (until the same would, but for such advance, become presently payable) pay interest at such rate (not exceeding without the sanction of the Company in general meeting six per cent) as may be agreed upon between the Member paying the sum in advance and the Directors.

#### FORFEITURE OF SHARES

- 21. If a Member fails to pay any call or instalment of a call on the day appointed for payment thereof, the Directors may, at any time thereafter during such time as any part of such call or instalment remains unpaid, serve a notice on him requiring payment of so much of the call or instalment as is unpaid, together with any interest which may have accrued.
- 22. The notice shall name a further day (not earlier than the expiration of fourteen days from the date of the notice) on or before which the payment required by the notice is to be made, and shall state that in the event of non-payment at or before the time appointed, the Shares in respect of which the call was made will be liable to be forfeited.
- 23. If the requirements of any such notice as aforesaid are not complied with, any Share in respect of which the notice has been given may at any time thereafter, before the payment required by the notice has been made, be forfeited by a resolution of the Directors to that effect.

- 24. A forfeited Share may be sold or otherwise disposed of on such terms and in such manner as the Directors think fit, and at any time before a sale or disposition, the forfeiture may be cancelled on such terms as the Directors think fit.
- 25. A person whose Shares have been forfeited shall cease to be a Member in respect of the forfeited Shares, but shall, notwithstanding, remain liable to pay to the Company all moneys which at the date of forfeiture were payable by him to the Company in respect of the Shares, but his liability shall cease if and when the Company receives payment in full of the amount due on the Shares.
- 26. A statutory declaration in writing that the declarant is a Director of the Company, and that a Share in the Company has been duly forfeited on a date stated in the declaration, shall be conclusive evidence of the facts therein stated as against all persons claiming to be entitled to the Share. The Company may receive the consideration, if any, given for the Share on any sale or disposition thereof and may execute a transfer of the Share in favour of the person to whom the Share is sold or disposed of and he shall thereupon be registered as the holder of the Share, and shall not be bound to see to the application of the purchase money, if any, nor shall his title to the Share be affected by any irregularity or invalidity in the proceedings in reference to the forfeiture, sale or disposal of the Share.
- 27. The provisions of these Articles as to forfeiture shall apply in the case of non-payment of any sum which, by the terms of issue of a Share, becomes payable at a fixed time, whether on account of the amount of the Share, or by way of premium, as if the same had been made payable by virtue of a call duly made and notified.

#### TRANSFER AND TRANSMISSION OF SHARES

- 28. The instrument of transfer of any Share shall be executed by or on behalf of the transferor and transferee, and the transferor shall be deemed to remain a holder of the Share until the name of the transferee is entered in the Register of Members in respect thereof.
- 29. Shares shall be transferred in the following form, or in any usual or common form approved by the Directors:

30. (a) The Directors may, in their absolute discretion and without assigning any reason therefor, decline to register any transfer of Shares to a person of whom they do not approve.

Transferor

(b) The Directors may also suspend the registration of transfers during the fourteen days immediately preceding the annual general meeting in each year.

Transferee

(c) The Directors may decline to recognise any instrument of transfer unless (a) a fee not exceeding one dollar is paid to the Company in respect thereof, and (b) the instrument of transfer is accompanied by the certificate of the Shares to which it relates, and such other evidence as the Directors may reasonably require to show the right of the transferor to make the transfer.

- (d) If the Directors refuse to register a transfer of Shares, they shall within one month after the date on which the transfer was lodged with the Company, send to the transferee notice of the refusal.
- 31. The legal personal representative of a deceased sole holder of a Share shall be the only person recognised by the Company as having any title to the Share. In case of a Share registered in the names of two or more holders, the survivors or survivor, or the legal personal representatives of the deceased survivor, shall be the only persons recognised by the Company as having any title to the Share.
- 32. Any person becoming entitled to a Share in consequence of the death or bankruptcy of a Member shall upon such evidence being produced as may from time to time be properly required by the Directors, have the right either to be registered as a Member in respect of the Share or, instead of being registered himself, to make such transfer of the Share as the deceased or bankrupt person could have made; but the Directors shall, in either case, have the same right to decline or suspend registration as they would have had in the case of a transfer of the Share by the deceased or bankrupt person before the death or bankruptcy.
- 33. A person becoming entitled to a Share by reason of the death or bankruptcy of the holder shall be entitled to the same dividends and other advantages to which he would be entitled if he were the registered holder of the Share, except that he shall not, before being registered as a Member in respect of the Share, be entitled in respect of it to exercise any right conferred by membership in relation to meetings of the Company.

### CONVERSION OF SHARES INTO STOCK

- 34. The Company may by Ordinary Resolution convert any paid-up Shares into stock, and reconvert any stock into paid-up Shares of any denomination.
- 35. The holders of stock may transfer the same, or any part thereof in the same manner and subject to the same regulations as and subject to which the Shares from which the stock arose might prior to conversion have been transferred, or as near thereto as circumstances admit; but the Directors may from time to time fix the minimum amount of stock transferable, and restrict or forbid the transfer of fractions of that minimum, but the minimum shall not exceed the nominal amount of the Shares from which the stock arose.
- 36. The holders of stock shall, according to the amount of the stock held by them, have the same rights, privileges and advantages as regards dividends, voting at meetings of the Company and other matters as if they held the Shares from which the stock arose, but no such privilege or advantage (except participation in the dividends and profits of the Company) shall be conferred by any such aliquot part of stock as would not, if existing as Shares, have conferred that privilege or advantage.
- 37. Such of the Articles of the Company as are applicable to paid-up Shares shall apply to stock, and the words "Share" and "Member" herein shall include "stock" and "stock-holder".

#### ALTERATION OF CAPITAL

- 38. The Company may from time to time by Ordinary Resolution increase the share capital by such sum, to be divided into new Shares of such amount, as the resolution shall prescribe.
- 39. Subject to any direction to the contrary that may be given by the Company in general meeting, all new Shares shall be at the disposal of the Directors in accordance with Article 6.

- 40. The new Shares shall be subject to the same provisions with reference to the payment of calls, lien, transfer, transmission, forfeiture and otherwise as the Shares in the original share capital.
- 41. The Company may by Ordinary Resolution:
  - (a) consolidate and divide all or any of its Share capital into Shares of larger amount than its existing Shares;
  - (b) sub-divide its existing Shares, or any of them, into Shares of smaller amount than is fixed by the Memorandum of Association, subject nevertheless to the provisions of section 13 of the Act: and
  - (c) cancel any Shares which, at the date of the passing of the resolution, have not been taken or agreed to be taken by any person.
- 42. Subject to the provisions of the Act and the Memorandum of Association, the Company may purchase its own Shares, including any redeemable Shares, provided that the manner of purchase has first been authorised by Ordinary Resolution and may make payment therefor or for any redemption or purchase of Shares in any manner authorised by the Act, including out of capital.
- 43. Subject to the provisions of the Act, the Company may accept the surrender for no consideration of any fully paid Share (including any redeemable Share) on such terms and in such manner as the Directors may determine.

#### **GENERAL MEETINGS**

- 44. The Company shall in each year hold a general meeting as its annual general meeting, provided that, if the Company is an exempted company, an annual general meeting need not be held unless determined by the Directors. The time and place of an annual general meeting shall be determined by the Directors.
- 45. General Meetings other than annual general meetings shall be called extraordinary general meetings. The Directors may call or authorise the calling of an extraordinary general meeting whenever they think fit.

### **REQUISITION OF GENERAL MEETINGS**

46. The Directors may whenever they think fit, convene an extraordinary general meeting. If at any time there are not sufficient Directors capable of acting to form a quorum, any Director or any one or more Members holding in the aggregate not less than one-third of the total issued share capital of the Company entitled to vote may convene an extraordinary general meeting in the same manner as nearly as possible as that in which meetings may be convened by the Directors. The Directors shall, upon the requisition in writing of one or more Members holding in the aggregate not less than one-tenth of such paid-up capital of the Company as at the date of the requisition carries the right of voting at general meetings, convene an extraordinary general meeting. Any such requisition shall express the object of the meeting proposed to be called, and shall be left at the Registered Office of the Company. If the Directors do not proceed to convene a general meeting within twenty-one days from the date of such requisition being left as aforesaid, the requisitionists or any or either of them or any other Member or Members holding in the aggregate not less than one-tenth of such paid-up capital of the Company as at the date of the requisition carries the right of voting at general meetings, may convene an extraordinary general meeting to be held at the Registered Office of the Company or at some convenient place within the Cayman Islands at

- such time, subject to the Company's Articles as to notice, as the persons convening the meeting fix.
- 47. Seven days notice at the least (exclusive of the day on which the notice is served or deemed to be served, but inclusive of the day for which the notice is given) specifying the place, the day and the hour of meeting and, in the case of special business, the general nature of that business shall be given in manner hereinafter provided, or in such other manner (if any) as may be prescribed by the Company in general meetings, to such persons as are entitled to vote or may otherwise be entitled under the Articles of the Company to receive such notices from the Company; but with the consent of all the Members entitled to receive notice of some particular meeting, that meeting may be convened by such shorter notice or without notice and in such manner as those Members may think fit.
- 48. The accidental omission to give notice of a meeting to, or the non-receipt of a notice of a meeting by, any Member entitled to receive notice shall not invalidate the proceedings at any meeting.
- 49. All business shall be deemed special that is transacted at an extraordinary general meeting, and all that is transacted at an annual general meeting shall be deemed special with the exception of sanctioning a dividend, the consideration of the accounts, balance sheets, the report of the Directors and Auditors, the election of Directors and other officers in the place of those retiring (if any) and the appointment and fixing of remuneration of Auditors.
- 50. (a) No business shall be transacted at any general meeting unless a quorum of Members is present at the time that the meeting proceeds to business; save as herein otherwise provided, one or more Members holding in the aggregate not less than one-third of the total issued share capital of the Company present in person or by proxy and entitled to vote shall be a quorum.
  - (b) An Ordinary Resolution or a Special Resolution (subject to the provisions of the Act) in writing signed by a majority of the total voting rights of all the Members entitled to vote at a general meeting of the Company or all the Members for the time being entitled to receive notice of and to attend and vote at general meetings respectively, (or being corporations by their duly authorised representatives) including a resolution signed in counterpart by or on behalf of such Members or by way of signed telefax transmission, shall be as valid and effective as if the same had been passed at a general meeting of the Company duly convened and held.
- 51. If within half an hour from the time appointed for the meeting a quorum is not present, the meeting, if convened upon the requisition of Members, shall be dissolved. In any other case it shall stand adjourned to the same day in the next week, at the same time and place, and if at the adjourned meeting a quorum is not present within half an hour from the time appointed for the meeting, the Members present shall be a quorum.
- 52. The chairman, if any, of the Board of Directors shall preside as chairman at every general meeting of the Company.
- 53. If there is no such chairman, or if at any meeting he is not present within fifteen minutes after the time appointed for holding the meeting or is unwilling to act as chairman, the Members present shall choose one of their number to be chairman.
- 54. The chairman may with the consent of any meeting at which a quorum is present (and shall if so directed by the meeting) adjourn the meeting from time to time and from place to place, but no business shall be transacted at any adjourned meeting other than the business left

unfinished at the meeting from which the adjournment took place. When a meeting is adjourned for ten days or more, notice of the adjourned meeting shall be given as in the case of an original meeting. Save as aforesaid it shall not be necessary to give any notice of an adjournment or of the business to be transacted at an adjourned meeting.

- 55. At any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands, unless a poll is (before or on the declaration of the result of the show of hands) demanded by one or more Members present in person or by proxy who together hold not less than fifteen per cent of the paid-up capital of the Company entitled to vote, and, unless a poll is so demanded, a declaration by the chairman that a resolution has, on a show of hands, been carried or carried unanimously, or by a particular majority, or lost and an entry to that effect in the minutes of the proceedings of the Company, shall be conclusive evidence of the fact, without proof of the number or proportion of the votes recorded in favour of, or against, that resolution.
- 56. If a poll is duly demanded it shall be taken in such manner as the chairman directs, and the result of the poll shall be deemed to be the resolution of the meeting at which the poll was demanded.
- 57. In the case of an equality of votes, whether on a show of hands or on a poll, the chairman of the meeting at which the show of hands takes place or at which the poll is demanded, shall be entitled to a second or casting vote.
- 58. A poll demanded on the election of a chairman or on a question of adjournment shall be taken forthwith. A poll demanded on any other question shall be taken at such time as the chairman of the meeting directs.

#### **VOTES OF MEMBERS**

- 59. On a show of hands every Member present in person or by proxy and entitled to vote shall have one vote. On a poll every Member present in person or by proxy and entitled to vote shall have one vote for each Share of which he is the holder.
- 60. In the case of joint holders the vote of the senior who tenders a vote whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holders; and for this purpose seniority shall be determined by the order in which the names stand in the Register of Members.
- 61. A Member of unsound mind, or in respect of whom an order has been made by any court having jurisdiction in lunacy, may vote, whether on a show of hands or on a poll, by his committee or other person in the nature of a committee appointed by that court, and any such committee or other person may vote by proxy.
- 62. No Member shall be entitled to vote at any general meeting, unless all calls or other sums presently payable by him in respect of Shares in the Company have been paid.
- 63. On a poll votes may be given either personally or by proxy.
- 64. The instrument appointing a proxy shall be in writing under the hand of the Member or, if the Member is a corporation, either under seal or under the hand of a director or officer or attorney duly authorised. A proxy need not be a Member of the Company. A vote given in accordance with the terms of an instrument of proxy shall be valid notwithstanding the previous death or insanity of the principal or revocation of the proxy or of the authority under which the proxy is given Provided that no intimation in writing of such death, insanity or revocation as aforesaid shall have been received by the Company at its

Registered Office before the commencement of the general meeting, or adjourned meeting, at which it is sought to use the proxy.

- 65. The instrument appointing a proxy shall be deposited at the Registered Office of the Company or at such other place as is specified for that purpose in the notice convening the meeting no later than the time for holding the meeting or adjourned meeting at which the person named in the instrument proposes to vote, and in default the instrument of proxy shall not be treated as valid PROVIDED that the chairman of the meeting may in his discretion accept an instrument of proxy sent by fax, email or other electronic means.

#### CORPORATIONS ACTING BY REPRESENTATIVES AT MEETING

67.

68. Any corporation which is a Member of the Company may by resolution of its directors or other governing body authorise such person as it thinks fit to act as its representative at any meeting of the Company or of any class of Members of the Company, and the person so authorised shall be entitled to exercise the same powers on behalf of the corporation which he represents as that corporation could exercise if it were an individual Member of the Company.

#### **DIRECTORS AND OFFICERS**

- 69. (a) The names of the first Directors shall be determined in writing by the subscribers of the Memorandum of Association.
  - (b) Notwithstanding any provision in these Articles to the contrary, a sole Director shall be entitled to exercise all of the powers and functions of the Directors which may be imposed on them by Act or by these Articles.
- 70. The remuneration of the Directors shall from time to time be determined by the Directors. The Directors shall also be entitled to be paid their travelling, hotel and other expenses properly incurred by them in going to, attending and returning from meetings of the Directors, or any committee of the Directors, or general meetings of the Company, or otherwise in connection with the business of the Company, or to receive a fixed allowance in respect thereof as may be determined by the Directors from time to time, or a combination partly of one such method and partly the other.
- 71. No Share holding qualification shall be required for Directors unless otherwise required by the Company by Ordinary Resolution.
- 72. Each Director shall have the power to nominate another Director or any other person to act as alternate Director in his place at any meeting of the Directors at which he is unable to be present and at his discretion to remove such alternate Director. On such appointment

being made the alternate Director shall (except as regards the power to appoint an alternate Director) be subject in all respects to the terms and conditions existing with reference to the other Directors of the Company and each alternate Director, whilst acting in the place of an absent Director, shall exercise and discharge all the functions powers and duties of the Director he represents. Any Director of the Company who is appointed as alternate Director shall be entitled at a meeting of the Directors to cast a vote on behalf of his appointor in addition to the vote to which he is entitled in his own capacity as a Director of the Company, and shall also be considered as two Directors for the purpose of making a quorum of Directors. Any person appointed as an alternate Director shall automatically vacate such office as such alternate Director if and when the Director by whom he has been appointed vacates his office of Director. The remuneration of an alternate Director shall be payable out of the remuneration of the Director appointing him and shall be agreed between them.

- 73. The Directors may by resolution appoint a managing director or president upon such terms as to duration of office, remuneration and otherwise as they may think fit.
- 74. The Directors may also by resolution appoint a Secretary and such other officers as may from time to time be required upon such terms as to duration of office, remuneration and otherwise as they may think fit. Such Secretary or other officers need not be Directors and in the case of the other officers may be ascribed such titles as the Directors may decide.

#### POWERS AND DUTIES OF DIRECTORS

- 75. The business of the Company shall be managed by the Directors, who may pay all expenses incurred in setting up and registering the Company and may exercise all such powers of the Company as are not, by the Act or these Articles, required to be exercised by the Company in general meeting, subject, nevertheless, to any clause of these Articles, to the provisions of the Act, and to such regulations, being not inconsistent with the aforesaid clauses or provisions, as may be prescribed by the Company in general meeting but no regulation made by the Company in general meeting shall invalidate any prior act of the Directors which would have been valid if that regulation had not been made.
- 76. The Directors may exercise all the powers of the Company to borrow money and to mortgage or charge its undertaking, property and uncalled capital or any part thereof, to issue debentures, debenture stock and other securities whenever money is borrowed or as security for any debt, liability or obligation of the Company or of any third party.
- 77. (a) The Directors may from time to time and at any time by power of attorney appoint any company, firm or person or body of persons, whether nominated directly or indirectly by the Directors, to be the attorney or attorneys of the Company for such purposes and with such powers, authorities and discretions (not exceeding those vested in or exercisable by the Directors under these Articles) and for such period and subject to such conditions as they may think fit, and any such appointment may contain such provisions for the protection and convenience of persons dealing with any such attorney as the Directors may think fit and may also authorise any such attorney to sub-delegate all or any of the powers, authorities and discretions vested in him.
  - (b) The Directors may delegate any of the powers exercisable by them to a managing director or any other person or persons acting individually or jointly as they may from time to time by resolution appoint upon such terms and conditions and with such restrictions as they may think fit, and may from time to time by resolution revoke, withdraw, alter or vary all or any such powers.

- (c) All cheques, promissory notes, drafts, bills of exchange and other negotiable instruments, and all receipts for moneys paid to the Company shall be signed, drawn, accepted, endorsed, or otherwise executed, as the case may be, in such manner as the Directors shall from time to time by resolution determine.
- (d) No document or deed otherwise duly executed and delivered by or on behalf of the Company shall be regarded as invalid merely because at the date of delivery of the deed or document, the Director, Secretary or other officer or person who shall have executed the same and/or affixed the Seal (if any) thereto as the case may be for and on behalf of the Company shall have ceased to hold such office or to hold such authority on behalf of the Company.
- 78. The Directors shall cause minutes to be prepared:-
  - (a) of all appointments of officers made by the Directors;
  - (b) of the names of the Directors or Alternate Directors present at each meeting of the Directors and of any committee of the Directors;
  - (c) of all resolutions and proceedings at all meetings of the Members of the Company and of the Directors and of committees of Directors; and the chairman of all such meetings or of any meeting confirming the minutes thereof shall sign the same.

#### DISOUALIFICATION AND CHANGES OF DIRECTORS

- 79. The office of Director shall be vacated if the Director:-
  - (a) becomes bankrupt or makes any arrangement or composition with his creditors generally; or
  - (b) is found to be or becomes of unsound mind; or
  - (c) resigns his office by notice in writing to the Company; or
  - (d) if he ceases to be a Director by virtue of, or becomes prohibited from being a Director by reason of, an order made under any provisions of any Act or enactment.
- 80. The number of Directors shall be not less than one, nor unless the Company in general meeting may otherwise determine, more than ten.
- 81. Any casual vacancy occurring in the Board of Directors may be filled by the Directors.
- 82. The Directors shall have the power at any time, and from time to time, to appoint a person as an additional Director or persons as additional Directors.
- 83. The Company may by Ordinary Resolution appoint and remove a Director or Directors.

#### PROCEEDINGS OF DIRECTORS

- 84. The Directors may meet together (either within or without the Cayman Islands) for the dispatch of business, adjourn, and otherwise regulate their meetings and proceedings, as they think fit. Questions arising at any meeting shall be decided by a majority of votes. In case of an equality of votes the chairman shall have a second or casting vote.
- 85. A Director or alternate Director may, and the Secretary on the requisition of a Director or alternate Director shall, at any time, summon a meeting of Directors by at least five days notice in writing to every Director and alternate Director which notice shall set forth the general nature of the business to be considered PROVIDED HOWEVER that notice may be waived by all the Directors (or their alternates) either at, before or after the meeting is held

PROVIDED FURTHER that notice or waiver thereof may be given by telex, telefax, electronic mail or other electronic means.

- 86. The quorum necessary for the transaction of the business of the Directors, may be fixed by the Directors and unless so fixed by the Directors, shall be two Directors or their proxies if there are two or more Directors, and shall be one if there is only one Director. For the purpose of this Article, an alternate appointed by a Director shall be counted in a quorum at a meeting at which the Director appointing him is not present.
- 87. The continuing Directors may act notwithstanding any vacancy in their body, but, if and so long as their number is reduced below the number fixed by or pursuant to the Articles of the Company as the necessary quorum of Directors, the continuing Directors may act for the purpose of increasing the number of Directors to that number, or of summoning a general meeting of the Company, but for no other purpose.
- 88. Any Director or officer may act by himself or his firm in a professional capacity for the Company, and he or his firm shall be entitled to remuneration for professional services as if he were not a Director or officer provided that nothing herein contained shall authorise a Director or officer or his firm to act as Auditor of the Company.
- 89. No person shall be disqualified from the office of Director or alternate Director or prevented by such office from contracting with the Company, either as vendor, purchaser or otherwise, nor shall any such contract or any contract or transaction entered into by or on behalf of the Company in which any Director or alternate Director shall be in any way interested be or be liable to be avoided, nor shall any Director or alternate Director so contracting or being so interested be liable to account to the Company for any profit realised by any such contract or transaction by reason of such Director holding office or of the fiduciary relation thereby established. A Director (or his alternate Director in his absence) shall be counted in the quorum of any relevant meeting which he attends and shall be at liberty to vote in respect of any contract or transaction in which he is so interested as aforesaid PROVIDED HOWEVER that the nature of the interest of any Director or alternate Director in any such contract or transaction shall be disclosed by him or the alternate Director appointed by him at or prior to its consideration and any vote thereon and a general notice that a Director or alternate Director is a shareholder of any specified firm or company and/or is to be regarded as interested in any transaction with such firm or company shall be sufficient disclosure hereunder and after such general notice it shall not be necessary to give special notice relating to any particular transaction.
- 90. The Directors may elect a chairman of their meetings and determine the period for which he is to hold office; but if no such chairman is elected, or if at any meeting the chairman is not present in person or his alternate Director within five minutes after the time appointed for holding the same, the Directors present may choose one of their number to be chairman of the meeting.
- 91. The Directors may delegate any of their powers to committees consisting of such member or members of their body as they think fit; any committee so formed shall, in the exercise of the powers so delegated, conform to any regulations that may be imposed on it by the Directors.
- 92. A committee may elect a chairman of its meetings; if no such chairman is elected, or if at any meeting the chairman is not present within five minutes after the time appointed for holding the same, the members present may choose one of their number to be chairman of the meeting.

- 93. A committee may meet and adjourn as it thinks proper. Questions arising at any meeting of the committee shall be determined by a majority of votes of the members present and in case of an equality of votes the chairman shall have a second or casting vote.
- 94. All acts done by any meeting of the Directors or of a committee of Directors, or by any person acting as a Director shall, notwithstanding that it be afterwards discovered that there was some defect in the appointment of any such Director or person acting as aforesaid, or that they or any of them were disqualified, be as valid as if every such person had been duly appointed and was qualified to be a Director.
- 95. (a) A resolution signed by all of the Directors or all of the members of a committee of Directors, including a resolution signed in counterpart or in the form of an Electronic Record, shall be as valid and effectual as if it had been passed at a meeting of the Directors or of a committee of Directors duly called and constituted.
  - (b) To the extent permitted by Act, the Directors or a committee of Directors may also meet by telephone conference call where all Directors or committee members are capable of speaking to and hearing the other Directors or committee members at the same time.
  - (c) When the chairman sign the minutes of a meeting of the Directors the same shall be deemed to have been duly held notwithstanding that the Directors have not actually come together physically or that there may have been a technical defect in the proceedings.

#### **SEALS AND DEEDS**

- 96. (a) If the Directors determine that the Company shall have a Seal, the Directors shall provide for the safe custody of the common Seal and the common Seal of the Company shall not be affixed to any instrument except by the authority of a resolution of the Directors, and in the presence of a Director or of the Secretary or of such other person as the Directors may appoint for the purpose; and that Director or the Secretary or other person as aforesaid shall sign every instrument to which the common Seal of the Company is so affixed in his presence. Notwithstanding the provisions hereof, annual returns and notices filed under the Act may be executed either as a deed in accordance with the Act or by the common Seal being affixed thereto in either case without the authority of a resolution of the Directors by one Director or the Secretary.
  - (b) The Company may maintain a facsimile of any common Seal in such countries or places as the Directors shall appoint and such facsimile Seal shall not be affixed to any instrument except by the authority of the Directors and in the presence of such person or persons as the Directors shall for this purpose appoint and such person or persons as aforesaid shall sign every instrument to which the facsimile Seal of the Company is so affixed in his presence and such affixing of the facsimile Seal and signing as aforesaid shall have the same meaning and effect as if the common Seal had been affixed in the presence of and the instrument signed by a Director or the Secretary or such other person as the Directors may appoint for the purpose.
  - (c) In accordance with the Act, the Company may execute any deed or other instrument which would otherwise be required to be executed under Seal by the signature of such deed or instrument as a deed by a Director or by the Secretary of the Company or by such other person as the Directors may appoint or authorise or by any other person or attorney on behalf of the Company appointed by a deed or other instrument executed as a deed by a Director or the Secretary or such other person as aforesaid.

#### DIVIDENDS, DISTRIBUTIONS AND RESERVE

- 97. Subject to the Act, these Articles, and the special rights attaching to Shares of any class, the Directors may, in their absolute discretion, declare dividends and distributions on Shares in issue and authorise payment of the dividends or distributions out of the funds of the Company lawfully available therefor.
- 98. The Directors may from time to time pay to the Members interim dividends.
- 99. No dividend or distribution shall be paid otherwise than out of realised or unrealised profits or out of the share premium account of the Company, or as otherwise permitted by the Act.
- 100. Subject to the rights of persons, if any, entitled to Shares with special rights as to dividends or distributions, all dividends or distributions on any class of Shares not fully paid shall be declared and paid according to the amounts paid on the Shares of that class, but if and so long as nothing is paid-up on any of the Shares in the Company, dividends or distributions may be declared and paid according to the number of Shares. No amount paid on a Share in advance of calls shall, while carrying interest, be treated for the purposes of this Article as paid on the Share.
- 101. The Directors may, before recommending any dividend or distributions, set aside out of the profits of the Company such sums as they think proper as a reserve or reserves which shall, at the discretion of the Directors, be applicable for meeting contingencies, or for equalising dividends, or for any other purpose to which the profits of the Company may be properly applied, and pending such application may, at the like discretion, either be employed in the business of the Company or be invested in such investments as the Directors may from time to time think fit.
- 102. If several persons are registered as joint holders of any Share, any of them may give effectual receipts for any dividend, distributions or other moneys payable on or in respect of the Share.
- 103. Any dividend or distribution may be paid by cheque or warrant sent through the post to the registered address of the Member or person entitled thereto or in the case of joint holders to any one of such joint holders at his registered address or to such person and such address as the Member or person entitled or such joint holders as the case may be may direct. Every such cheque or warrant shall be made payable to the order of the person to whom it is sent or to the order of such other person as the Member or person entitled or such joint holders as the case may be may direct.
- 104. The Directors may declare that any dividend or distribution is paid wholly or partly by the distribution of specific assets and in particular of paid-up shares, debentures or debenture stock of any other company or in any one or more of such ways, and the Directors shall give effect to such resolution, and where any difficulty arises in regard to such distribution, the Directors may settle the same as they think expedient, and in particular may issue fractional certificates and fix the value for distribution of such specific assets or any part thereof and may determine that cash payments shall be made to any Members upon the footing of the value so fixed in order to adjust the rights of all parties, and may vest any such specific assets in trustees as may seem expedient to the Directors.
- 105. No dividend or distribution shall bear interest against the Company. All unclaimed dividends or distributions may be invested or otherwise made use of by the Directors for the benefit of the Company until claimed. Any dividend or distribution unclaimed by a Member six years after the dividend or distribution payment date shall revert to the Company.

#### **CAPITALISATION OF PROFITS**

106. The Company may upon the recommendation of the Directors by Ordinary Resolution authorise the Directors to capitalise any sum standing to the credit of any of the Company's reserve accounts (including share premium account and capital redemption reserve fund) or any sum standing to the credit of the profit and loss account or otherwise available for distribution and to appropriate such sums to Members in the proportions in which such sum would have been divisible amongst them had the same been a distribution of profits by way of dividend and to apply such sum on their behalf in paying up in full unissued Shares for allotment and distribution credited as fully paid-up to and amongst them in the proportion aforesaid. In such event the Directors shall do all acts and things required to give effect to such capitalisation, with full power to the Directors to make such provision as they think fit for the case of Shares becoming distributable in fractions (including provision whereby the benefit of fractional entitlements accrue to the Company rather than to the Members concerned). The Directors may authorise any person to enter on behalf of all the Members interested into an agreement with the Company providing for such capitalisation and matters incidental thereto and any agreement made under such authority shall be effective and binding on all concerned.

#### **ACCOUNTS**

- 107. The books of account relating to the Company's affairs shall be kept in accordance with the Act and otherwise in such manner as may be determined from time to time by the Directors of the Company.
- 108. Such Auditors may be appointed and the accounts relating to the Company's affairs may be audited in such manner as may be determined by the Directors.

#### **CONTINUATION**

109. Subject to the provisions of the Act and any applicable laws, the Company may by Special Resolution together with a resolution of Directors, apply to the Registrar to be deregistered in the Cayman Islands, and register by way of continuation as a body corporate limited by shares under the laws of any jurisdiction outside the Cayman Islands.

#### WINDING UP

- 110. If the Company shall be wound up, the liquidator may, with the sanction of a Special Resolution of the Company and any other sanction required by the Act, divide amongst the Members in specie or kind the whole or any part of the assets of the Company (whether they shall consist of property of the same kind or not) and may for such purpose set such value as he deems fair upon any property to be divided as aforesaid and may determine how such division shall be carried out as between the Members or different classes of Members. The liquidator may with the like sanction, vest the whole or any part of such assets in trustees upon such trusts for the benefit of the contributories as the liquidator, with the like sanction, shall think fit, but so that no Member shall be compelled to accept any Shares or other securities whereon there is any liability.
- 111. If the Company shall be wound up and the assets available for distribution amongst the Members as such shall be insufficient to repay the whole of the paid-up capital, such assets shall be distributed so that, as nearly as may be, the losses shall be borne by the Members in proportion to the capital paid up, or which ought to have been paid up, at the commencement of the winding up, on the Shares held by them respectively. And if in a winding up the assets available for distribution amongst the Members shall be more than

sufficient to repay the whole of the capital paid up at the commencement of the winding up, the excess shall be distributed amongst the Members in proportion to the capital paid up at the commencement of the winding up on the Shares held by them respectively. This Article is to be without prejudice to the rights of the holders of Shares issued upon special terms and conditions.

#### NOTICES

- 112. (a) A notice may be given by the Company to any Member either personally or by sending it by post, electronic mail, telex or telefax to him to his registered address, or (if he has no registered address) to the address, if any, supplied by him to the Company for the giving of notices to him.
  - (b) Where a notice is sent by post, service of the notice shall be deemed to be effected by properly addressing, prepaying, and posting a letter containing the notice (by airmail if available) and to have been effected, in the case of a notice of a meeting at the expiration of three days after it was posted.
  - (c) Where a notice is sent by telex, electronic mail or telefax, service of the notice shall be deemed to be effected by properly addressing and sending such notice through the appropriate transmitting medium and to have been effected on the day the same is sent.
- 113. If a Member has no registered address and has not supplied to the Company an address for the giving of notice to him, a notice addressed to him and advertised in a newspaper circulating in the Cayman Islands shall be deemed to be duly given to him at noon on the day following the day on which the newspaper is circulated and the advertisement appeared therein.
- 114. A notice may be given by the Company to the joint holders of a Share by giving the notice to the joint holder named first in the Register of Members in respect of the Share.
- 115. A notice may be given by the Company to the person entitled to a Share in consequence of the death or bankruptcy of a Member by sending it through the post in a prepaid letter addressed to them by name, or by the title of representatives of the deceased, or trustee of the bankrupt, or by any like description, at the address, if any, supplied for the purpose by the persons claiming to be so entitled, or (until such an address has been so supplied) by giving the notice in any manner in which the same might have been given if the death or bankruptcy had not occurred.
- 116. Notice of every general meeting shall be given in some manner hereinbefore authorised to:
  - (a) every Member entitled to vote except those Members entitled to vote who (having no registered address) have not supplied to the Company an address for the giving of notices to them; and
  - (b) every person entitled to a Share in consequence of the death or bankruptcy of a Member, who, but for his death or bankruptcy would be entitled to receive notice of the meeting.

No other persons shall be entitled to receive notices of general meetings.

#### RECORD DATE

117. The Directors may fix in advance a date as the record date for any determination of Members entitled to notice of or to vote at a meeting of the Members and, for the purpose of determining the Members entitled to receive payment of any dividend, the Directors may, at

or within 90 days prior to the date of the declaration of such dividend, fix a subsequent date as the record date for such determination.

#### AMENDMENT OF MEMORANDUM AND ARTICLES

118. Subject to and insofar as permitted by the provisions of the Act, the Company may from time to time by Special Resolution alter or amend its Memorandum of Association or these Articles in whole or in part Provided however that no such amendment shall affect the rights attaching to any class of Shares without the consent or sanction provided for in Article 3(b).

#### **ORGANISATION EXPENSES**

119. The preliminary and organisation expenses incurred in forming the Company shall be paid by the Company and may be amortised in such manner and over such period of time and at such rate as the Directors shall determine and the amount so paid shall in the accounts of the Company, be charged against income and/or capital.

#### OFFICES OF THE COMPANY

120. The Registered Office of the Company shall be at such address in the Cayman Islands as the Directors shall from time to time determine. The Company, in addition to its Registered Office, may establish and maintain an office in the Cayman Islands or elsewhere as the Directors may from time to time determine.

#### **INDEMNITY**

Every Director and officer for the time being of the Company or any trustee for the time 121. being acting in relation to the affairs of the Company and their respective heirs, executors. administrators, personal representatives or successors or assigns shall, in the absence of wilful neglect or default, be indemnified by the Company against, and it shall be the duty of the Directors out of the funds and other assets of the Company to pay, all costs, losses, damages and expenses, including travelling expenses, which any such Director, officer or trustee may incur or become liable in respect of by reason of any contract entered into, or act or thing done by him as such Director, officer or trustee or in any way in or about the execution of his duties and the amount for which such indemnity is provided shall immediately attach as a lien on the property of the Company and have priority as between the Members over all other claims. No such Director, officer or trustee shall be liable or answerable for the acts, receipts, neglects or defaults of any other Director, officer or trustee or for joining in any receipt or other act for conformity or for any loss or expense happening to the Company through the insufficiency or deficiency of any security in or upon which any of the monies of the Company shall be invested or for any loss of any of the moneys of the Company which shall be invested or for any loss or damage arising from the bankruptcy, insolvency or tortious act of any person with whom any monies, securities or effects shall be deposited, or for any other loss, damage or misfortune whatsoever which shall happen in or about the execution of the duties of his respective office or trust or in relation thereto unless the same happen through his own wilful neglect or default.

## 二、標的公司概況

## (一)公司背景

芮特科技股份有限公司(Radiation Technology,Inc)於 103 年 8 月 18 日於英屬開曼群島設立,主要係為向財團法人中華民國證券櫃買中心(以下簡稱櫃買中心)之上櫃股票買賣申請所進行之組織架構重組而設立,於 103 年 9 月重組後成為所有合併個體之控股公司,股票於 104 年 12 月 2 日起於櫃買中心掛牌交易。

本公司之母公司為 UMT Holdings (Samoa) Limited(以下簡稱 UMT Samoa),最終母公司為昇達公司。截至目前止,昇達公司直接及間接透過 UMT Samoa 持有本公司普通股股權共計 55.59%。

芮特科技股份有限公司主要經營業務為銷售及生產天線、射頻線、 射頻連接器與線束等電子元器件。111 年度之主要產品比重為天線及通 訊零件92.6%及其他7.4%。

### 三、評價模式

#### (一) 股權評價方法說明

依評價準則第四號第 15 條,評價人員應依專業判斷,考量評價案件之性質及所有可能之常用評價方法,採用最適用於評價案件並最能合

理反應標的公司價值之評價方法;依據評價準則第十一號第 17 條常見 有市場法、收益法及資產法,茲分別說明如下:

- 1.市場法:包括市價法、可類比公司法及可類比交易法,主要係以市場 上具可比較性之同類型公司或類似交易之價值倍數作為參 考,再根據標的公司本身異於市場同業或交易之部分調整, 藉以分析與計算評估標的公司的近期營運表現對應市場價 值。
- 2.收益法:例如現金流量法,以評價標的公司所創造未來營運所產生之 現金流量為評估基礎,透過資本化或折現過程,將未來之現 金流量轉換為評價標的公司之企業價值。
- 3.資產法:係以帳面之歷史成本資料為評價基礎,即以資產負債表之資 產減負債後之帳面價值,並考量資產及負債市場價格而進行 帳面價值之調整,以反映標的公司整體價值。

## (二) 評估方法之選用

前述方法中,因收益法下高度仰賴預估財務資訊,包括營業收入、 預估損益、資本投入及相關現金流量等,其中涉及過多假設性項目及參 數運用,具有較高之不確定性,因此擬不採用收益法評估。另資產法係 經由評價標的公司之個別資產及個別負債,耗費時間且不易涵蓋所有資 產及負債,通常適用於資產占企業價值高之企業、控股公司及清算公司 等,本意見書不擬依資產法評估。

由於芮特 KY 公司之股權已於櫃買中心上櫃,股權可於證券市場中交易,並具活絡可自由流通性,其股價最具參考價值,因此選用市場法下之市價法;另以標的公司所屬產業之台灣上市櫃之可類比同業,採可類比公司法之本益比法及股價淨值比法,計算出所隱含之價值乘數以作為標的公司股價格合理性之評估基礎。

有關可類比公司法之價值乘數之選擇,實務上常見公司績效衡量指標包括收入、盈餘及權益帳面金額等,可類比公司法即係以績效衡量值

推估股權價值為基礎,因此形成股價營收比法、本益比法及股價淨值比法,此三種方法計算容易加上股價及相關財務資訊易取得,是一般投資人進行股票估值評估是否買貴或買便宜之指標。因此本會計師於進行可類比公司法選用其中之本益比法及股價淨值比法,未選用股價營收比法主要原因係該方法常用於新創導入期或者成長期之公司,該類公司常未進入獲利階段,因此不適合納入本案進行評估。

## 四、評價標的股權價值計算

## (一) 市價法

由於芮特 KY 為上櫃公司,具備客觀之公開市場交易價格可參考,本意見書採樣標的公司近期之公開交易價格,係以 113 年 3 月 8 日(含)前 10、20、30 及 60 個營業日之收盤價作為設算芮特 KY 公司每股股權合理參考價值之基礎如下:

如標的公司概況之公司背景所述, 芮特 KY 公司是主要從事銷售 及設計生產各式天線、射頻線與射頻連接器等電子元器件業務, 111 年度營業產品為天線及通訊零件(92.6%)及其他(7.4%)。本意見書參 酌標的公司所屬產業、銷售產品選取較為相近之上市櫃同業名單作 為可頻比公司, 可頻比同業為詠業(股票代碼 6792)、耀登(股票代碼 3138)、榮昌(股票代碼 3684)、佳邦(股票代碼 6284)及謹裕(股票代碼 3419), 最近年度產品比重彙總如下表:

## (三) 非量化調整因素-溢價率

基於本案評價之目的,其收購價格應隱含溢酬,因此本案採自 109 年以來台灣透過股份轉換及反式三角合併下市案之溢價率,並以與案件 最為攸關之公告日前一日收盤價之股權溢價率作基礎,採用統計上常用 之四分位數法,採股權溢價率之第一四分位數 6.57%為下限,第三四分 位數 21.35%為上限作為非量化調整之區間,其案件如附件二。

## (四) 股權價值評估之彙總

依前述評價模式結果,由於芮特 KY 公司為證券櫃檯買賣中心之上櫃公司,具備客觀之公開市場交易價格可參考,因此以市價法為主要評估方法;其餘方法以係採用過去每股盈餘及每股淨值與可類比公司之財務乘數推估,因此給予可類比公司法較低權重以計算股權價值;並考量非量化調整之溢價率調整每股價格為之,本案芮特 KY 公司每股股權價格合理區間如下:

## 五、股權價格合理性意見結論

本會計師經考量可量化之財務數字及市場客觀資料,分別以市價法、可類 比公司法之本益比法及股價淨值比法,並考量非量化調整之溢價率加以計算後, 其評估計算結果, 芮特 KY 公司股權之合理每股價格區間應介於新台幣 52.80 元~62.18 元;本合併案之合併對價為每股新台幣 53.80 元,其合併對價介於前 述所評估之每股價格區間內,應屬允當合理。

## 附件一、評價之假設及限制條件

- 由於企業之內部與外部因素將重大影響其價值評估,因此本意見書中 所揭露之資訊,對於價值結論相當重要且關係密切,本意見書並未隱 瞞任何必要之資訊。
- 2.企業評價係基於所取得之資料,設定某些假設條件而出具報告,故不同評價人員所評估之結果,亦存在差異。本會計師係使用目前一般接受之評價方法及評價流程,對芮特 KY 公司股權之價值表示意見,惟本會計師未對交易價格提出任何保證。
- 3.本會計師主要業務並非提供法律專業之服務,因此任何將影響評價之 法律訴訟,本會計師無法以專業律師之觀點來判斷。
- 4.本意見書僅供昇達公司基於本案之評價目的使用,非經本會計師書面 同意,不得提供予其他第三者使用,亦不得作為其他用途,本會計師 不對第三者負擔責任。
- 5.本會計師假設芮特 KY 公司所處政經環境、利率、匯率與相關法規無重大改變且產業發展符合預期,並未考慮非預期變化對芮特 KY 公司股權價值之影響。本意見書出具後,如實際情況變更,非經受任重新評估,本會計師將不再更新。
- 6.本會計師依據財團法人中華民國會計研究發展基金會發布之評價準 則公報第十一號「企業之評價」第七條之規定,已針對芮特 KY 公司 於公開市場可取得之資訊進行合理性評估,確認其來源之可靠性與適 當性。惟基於所受委任範圍,本會計師並未對前述資訊依審計準則進 行查核工作或依財團法人中華民國會計研究發展基金會發布之確信 準則 3000 號「非屬歷史性財務資訊查核或核閱之確信案件」執行確 信程序,故對其正確性或允當性無法提供任何程度之確信。
- 7.本會計師假設芮特 KY 公司截至評價基準日無重大未決事項、訴訟(包括稅務及其他法律糾紛)及或有負債可能影響芮特 KY 公司股權價值 之事項。

- 第一條 為建立本公司良好董事會治理制度、健全監督功能及強化管理機能,爰 依證券交易法(以下簡稱本法)第二十六條之三第八項規定訂定之。
- 第二條 本公司董事會之議事規範,除法令或章程另有規定者外,應依本規範之 規定辦理。
- 第三條 本公司董事會每季召集乙次,召集時應載明事由,於七日前通知各董事, 但遇有緊急情事時,得不經書面通知隨時召集之。

前項召集之通知,經相對人同意者,得以電子方式為之。

第七條第一項各款之事項,除有突發緊急情事或正當理由外,應在召集 事由中列舉,不得以臨時動議提出。

第四條 本公司董事會指定辦理議事事務單位為管理部。議事單位應擬訂董事會 議事內容,並提供充分之會議資料,於召集通知時一併寄送。

- 第五條 董事會之召開,應於本公司所在地及辦公時間內為之。但為業務需要, 得於其他便利董事出席且適合董事會召開之地點及時間為之。
- 第六條 定期性董事會之議事內容,至少包括下列事項:

    - (三)內部稽核業務報告。
    - (四)其他重要報告事項。
  - 二、討論事項:
    - (一)上次會議保留之討論事項。
    - (二)本次會議討論事項。
  - 三、臨時動議。
- 第七條 公司對於下列事項應提董事會討論:
  - 公司對於下列事項應提董事會討論:
  - 一、公司之營運計畫。
  - 二、年度財務報告及須經會計師查核簽證之第二季財務報告。
  - 三、依本法第十四條之一規定訂定或修正內部控制制度,及內部控制制 度有效性之考核。
  - 四、依本法第三十六條之一規定訂定或修正取得或處分資產、從事衍生性商品交易、資金貸與他人、為他人背書或提供保證之重大財務業務行為之處理程序。
  - 五、募集、發行或私募具有股權性質之有價證券。
  - 六、董事會未設常務董事者,董事長之選任或解任。
  - 七、財務、會計或內部稽核主管之任免。
  - 八、對關係人之捐贈或對非關係人之重大捐贈。但因重大天然災害所為 急難救助之公益性質捐贈,得提下次董事會追認。
  - 九、依本法第十四條之三、其他依法令或章程規定應由股東會決議或董 事會決議之事項或主管機關規定之重大事項。

前項第七款所稱關係人指證券發行人財務報告編製準則所規範之關

係人;所稱對非關係人之重大捐贈,指每筆捐贈金額或一年內累積對同一對象捐贈金額達新臺幣一億元以上,或達最近年度經會計師簽證之財 務報告營業收入淨額百分之一或實收資本額百分之五以上者。

前項所稱一年內係以本次董事會召開日期為基準,往前追溯推算一 年,已提董事會決議通過部分免再計入。

公司設有獨立董事者,應有至少一席獨立董事親自出席董事會;對於第一項應提董事會決議事項,應有全體獨立董事出席董事會,獨立董事如無法親自出席,應委由其他獨立董事代理出席。獨立董事如有反對或保留意見,應於董事會議事錄載明;如獨立董事不能親自出席董事會表達反對或保留意見者,除有正當理由外,應事先出具書面意見,並載明於董事會議事錄。

第八條 本公司除前條第一項應提董事會討論事項外,董事會依法令或公司章程 規定,授權董事長行使董事會職權之內容或事項如下:

- 一、召集董事會並執行其決議。
- 二、營運計劃之擬定。
- 三、與營業相關之章則及契約之審定。
- 四、與營業相關之財產購置及處份之核定。
- 五、與營業相關之人員調動及各部門員額之核定。
- 六、預算決算及營業報告書等草案之編審。
- 七、資本增減、盈餘分配或虧損彌補草案之研擬。
- 第九條 召開董事會時,應設簽名簿供出席董事簽到,並供查考。

董事應親自出席董事會,如不能親自出席,得依公司章程規定委託其他 董事代理出席;如以視訊參與會議者,視為親自出席,但應傳真簽到卡 以代簽到。

董事委託其他董事代理出席董事會時,應於每次出具委託書,並列舉召集事由之授權範圍。

第二項代理人,以受一人之委託為限。

第十條 本公司董事會由董事長召集者,由董事長擔任主席。但每屆第一次董事 會,由股東會所得選票代表選舉權最多之董事召集者,會議主席由該召 集權人擔任之,召集權人有二人以上時,應互推一人擔任之。

依公司法第二百零三條第四項或第二百零三條之一第三項規定董事會由過半數之董事自行召集者,由董事互推一人擔任主席。

董事長請假或因故不能行使職權時,由副董事長代理之,無副董事長或副董事長亦請假或因故不能行使職權時,由董事長指定常務董事一人代理之;其未設常務董事者,指定董事一人代理之,董事長未指定代理人者,由常務董事或董事互推一人代理之。

第十一條 董事會召開時,管理部應備妥相關資料供與會董事隨時查考。

董事會進行中,得視議案內容通知相關部門或子公司之人員列席會議,報告目前公司業務概況及答覆董事提問事項,以協助董事瞭解公司現況,作出適當決議。另亦得邀請會計師、律師或其他專業人士列席會議及說明,提供專家意見以供董事會參考。但討論及表決時應離席。

第十二條 董事會之主席於已屆開會時間並有過半數之董事出席時,應即宣布開會。但未有過半數之董事出席時,主席得宣布延後開會,其延後次數以二次為限,延後二次仍不足額者,主席得依第三條第二項規定之程序重行召集,始得再行集會。

前項及第十七條第二項第二款所稱全體董事,以實際在任者計算之。

第十三條 本公司董事會應依會議通知所排定之議事程序進行,但經出席董事過半 數同意者,得變更之。

非經出席董事過半數同意者,主席不得逕行宣布散會。

會議進行中,主席得酌定時間宣布休息或協商。

董事會議事進行中,若在席董事未達出席董事過半數者,經在席董事提 議,主席應宣布暫停開會,並準用前條第一項規定。

第十四條 主席對於議案之討論,認為已達可付表決之程度時,得宣布停止討論, 提付表決。

> 議案表決時,經主席徵詢出席董事全體無異議者,視為通過。如經主席 徵詢而有異議者,即應提付表決。

> 表決方式由主席就下列各款規定擇一行之,但出席董事有異議時,應徵求多數之意見決定之:

- 一、舉手表決或投票器表決。
- 二、唱名表決。
- 三、投票表決。

四、公司自行選用之表決。

議案之表決如有設置監票及計票人員之必要者,由主席指定之,但監票 人員應具董事身分。

表決之結果,應當場報告,並做成紀錄。

本條所稱出席董事不包括依第十六條所規定不得行使表決權之董事。

第十五條 議案之表決,除公司法及本公司章程另有規定外,以出席董事 過半數之同意通過之。

> 同一議案有修正案或替代案時,由主席併同原案定其表決之順序。但如其中一案已獲通過時,其他議案即視為否決,無須再 行表決。

第十六條 董事對於會議事項,與其自身或其代表之法人有利害關係者,應於當次 董事會說明其利害關係之重要內容,如有害於公司利益之虞時,不得加 入討論及表決,且討論及表決時應予迴避,並不得代理其他董事行使其 表決權。

董事之配偶、二親等內血親,或與董事具有控制從屬關係之公司,就會議之事項有利害關係者,視為董事就該事項有自身利害關係。

本公司董事會之決議,對依前項規定不得行使表決權之董事,依公司法第二百零六條第四項準用第一百八十條第二項規定辦理。

- 七、討論事項:各議案之決議方法與結果、董事、專家及其他人員發言 摘要、依前條第一項規定涉及利害關係之董事姓名、利害關係重 要內容之說明、其應迴避或不迴避理由、迴避情形、反對或保留 意見且有紀錄或書面聲明及獨立董事依第七條第五項規定出具之書 面意見。
- 八、臨時動議:提案人姓名、議案之決議方法與結果、董事、專家及其他人員發言摘要、依前條第一項規定涉及利害關係之董事姓名、利害關係重要內容之說明、其應迴避或不迴避理由、迴避情形及反對或保留意見且有紀錄或書面聲明。

九、其他應記載事項。

董事會之議決事項,如有獨立董事有反對或保留意見且有紀錄或書面聲明者,除應於議事錄載明外,並應於董事會之日起二日內於主管機關指定之資訊申報網站辦理公告申報。

董事會簽到簿為議事錄之一部分,應於公司存續期間妥善保存。 議事錄須由會議主席及記錄人員簽名或蓋章,於會後二十日內分送 各董事,並應列入公司重要檔案,於公司存續期間妥善保存。

第一項議事錄之製作及分發,得以電子方式為之。

第十八條 董事會之開會過程,應全程錄音或錄影存證,並至少保存五年,其保存 得以電子方式為之。

前項保存期限未屆滿前,發生關於董事會相關議決事項之訴訟時,相關錄音或錄影存證資料應續予保存至訴訟終結止。

以視訊會議召開者,其視訊影音資料為議事錄之一部分,應於公司存續期間妥善保存。

第一條 本公司股東會之議事規則,除法令或章程另有規定者外,應依本規則之規定。

第二條 本公司股東會除法令另有規定外,由董事會召集之。

股東常會之召集,應編製議事手冊,並於三十日前通知各股東,對於持有記名股票未滿一千股股東,得於三十日前以輸入主管機關指定申報網站公告方式為之; 股東臨時會之召集,應於十五日前通知各股東,對於持有記名股票未滿一千股股東,得於十五日前以輸入主管機關指定申報網站公告方式為之。

通知及公告應載明召集事由; 其通知經相對人同意者, 得以電子方式為之。

選任或解任董事、變更章程、減資、申請停止公開發行、董事競業許可、盈餘轉增資、公積轉增資、公司解散、合併、分割或公司法第一百八十五條第一項各款、證券交易法第二十六條之一、第四十三條之六、發行人募集與發行有價證券處理準則第五十六條之一及第六十條之二之事項,應在召集事由中列舉並說明其主要內容,不得以臨時動議提出。

股東會召集事由已載明全面改選董事,並載明就任日期,該次股東會改選完成後,同次會議不得再以臨時動議或其他方式變更其就任日期。

持有已發行股份總數百分之一以上股份之股東,得以書面向本公司提出股東常會議案,以一項為限,提案超過一項者,均不列入議案。但股東提案係為敦促公司增進公共利益或善盡社會責任之建議,董事會仍得列入議案。另股東所提議案有公司法第一百七十二條之一第四項各款情形之一,董事會得不列為議案。

本公司應於股東常會召開前之停止股票過戶日前,公告受理股東之提案、書面或電子受理方式、受理處所及受理期間;其受理期間不得少於十日。

股東所提議案以三百字為限,超過三百字者,不予列入議案;提案股東應親自或委託他人出席股東常會,並參與該項議案討論。

本公司應於股東會召集通知日前,將處理結果通知提案股東,並將合於本條規定之議案列於開會通知。對於未列入議案之股東提案,董事會應於股東會說明未列入之理由。

第三條 股東得於每次股東會,出具本公司印發之委託書,載明授權範圍,委託代理人, 出席股東會。一股東以出具一委託書,並以委託一人為限,應於股東會開會五日 前送達本公司,委託書有重複時,以最先送達者為準。但聲明撤銷前委託者,不 在此限。

委託書送達本公司後,股東欲親自出席股東會者,至遲應於股東會開會二日前,以書面向本公司為撤銷委託之通知;逾期撤銷者,以委託代理人出席行使之表決權為準。

第四條 股東會召開之地點,應於本公司所在地或便利股東出席且適合股東會召開之地點為之,會議開始時間不得早於上午九時或晚於下午三時,召開之地點及時間,應 充分考量獨立董事之意見。 第五條 本公司應設簽名簿供出席股東本人或股東所委託之代理人(以下稱為股東)簽 到,或由出席股東繳交簽到卡以代簽到,出席股數依簽名簿或繳交之簽到卡計算 之。

本公司應將議事手冊、年報、出席證、發言條、表決票及其他會議資料,交付予出席股東會之股東;有選舉董事者,應另附選舉票。

股東應憑出席證、出席簽到卡或其他出席證件出席股東會;屬徵求委託書之徵求 人並應携帶身分證明文件,以備核對。

政府或法人為股東時,出席股東會之代表人不限於一人。法人受託出席股東會時,僅得指派一人代表出席。

第六條 股東會如由董事會召集者,其主席由董事長擔任之,董事長請假或因故不能行使 職權時,由副董事長代理之,無副董事長或副董事長亦請假或因故不能行使職權 時,由董事長指定常務董事一人代理之;其未設常務董事者,由董事長指定董事 一人代理之;董事長未指定代理人者,由常務董事或董事互推一人代理之。

董事會所召集之股東會,宜有董事會過半數之董事參與出席。股東會如由董事會以外之其他有召集權人召集者,其主席由該召集權人擔任之,召集權人有二人以上時,應互推一人擔任之。

本公司得指派所委任之律師、會計師或相關人員列席股東會。

- 第七條 股東會之開會過程應全程錄音或錄影,並至少保存一年。但經股東依公司法第一 百八十九條提起訴訟者,應保存至訴訟終結為止。
- 第八條 股東會之出席,應以股份為計算基準。出席股數依簽名簿或繳交之簽到卡,加計 以書面或電子方式行使表決權之股數計算之。

已屆開會時間,主席應即宣布開會,並同時公布無表決權數及出席股份數等相關 資訊。

惟未有代表已發行股份總數過半數之股東出席時,主席得宣布延後開會,其延後次數以二次為限,延後時間合計不得超過一小時。

延後二次仍不足額而有代表已發行股份總數三分之一以上股東出席時,得依公司 法第一百七十五條第一項規定為假決議。

於當次會議未結束前,如出席股東所代表股數達已發行股份總數過半數時,主席得將作成之假決議,依公司法第一百七十四條規定重新提請股東會表決。

第九條 股東會如由董事會召集者,其議程由董事會訂定之,相關議案(包括臨時動議及原議案修正)均應採逐案票決,會議應依排定之議程進行,非經股東會決議不得變更之。

股東會如由董事會以外之其他有召集權人召集者,準用前項之規定。

前二項排定之議程於議事(含臨時動議)未終結前,非經決議,主席不得逕行宣布 散會。主席違反議事規則,宣布散會者,董事會其他成員應迅速協助出席股東依 法定程序,以出席股東表決權過半數之同意推選一人擔任主席,繼續開會。

會議散會後,股東不得另推選主席於原址或另覓場所續行開會。

主席對於議案及股東所提之修正案或臨時動議,應給予充分說明及討論之機會,認為已達可付表決之程度時,得宣布停止討論,提付表決。並安排適足之投票時

間。

第十條 出席股東發言前,須先填具發言條載明發言要旨、股東戶號 (或出席證編號)及 戶名,由主席定其發言順序。

出席股東僅提發言條而未發言者,視為未發言;發言內容與發言條記載不符者, 以發言內容為準。

同一議案每一股東發言,非經主席之同意不得超過兩次,每次不得超過五分鐘。 惟股東發言違反前項規定或超出議題範圍者,主席得制止其發言。

出席股東發言時,其他股東除經徵得主席及發言股東同意外,不得發言干擾,違 反者主席應予制止。

法人股東指派二人以上之代表出席股東會時,同一議案僅得推由一人發言。 出席股東發言後,主席得親自或指定相關人員答覆。

第十一條 股東會之出席及表決,應以股份為計算基準。

股東會之決議,對無表決權股東之股份數,不算入已發行股份之總數。

股東對於會議之事項,有自身利害關係致有害於本公司利益之虞時,不得加入表 決,並不得代理他股東行使其表決權。

前項不得行使表決權之股份數,不算入已出席股東之表決權數。

除信託事業或經證券主管機關核准之股務代理機構外,一人同時受二人以上股東 委託時,其代理之表決權不得超過已發行股份總數表決權之百分之三,超過時其 超過之表決權,不予計算。

第十二條 本公司股東除法令另有規定外,每股有一表決權。

本公司召開股東會時,應採行以電子方式並得採行以書面方式行使其表決權;其以書面或電子方式行使表決權時,其行使方法應載明於股東會召集通知。以書面或電子方式行使表決權之股東,視為親自出席股東會。但就該次股東會之臨時動議及原議案之修正,視為棄權。故本公司宜避免提出臨時動議及原議案之修正。前項以書面或電子方式行使表決權者,其意思表示應於股東會開會二日前送達公司,意思表示有重複時,以最先送達者為準。但聲明撤銷前意思表示者,不在此限。

股東以書面或電子方式行使表決權後,如欲親自出席股東會者,至遲應於股東會開會二日前以與行使表決權相同之方式撤銷前項行使表決權之意思表示;逾期撤銷者,以書面或電子方式行使之表決權為準。如以書面或電子方式行使表決權並以委託書委託代理人出席股東會者,以委託代理人出席行使之表決權為準。

議案之表決,除公司法及本公司章程另有規定外,以出席股東表決權過半數之同意通過之。表決時,應逐案由主席或其指定人員宣佈出席股東之表決權總數。議案經主席徵詢全體出席股東無異議者,視為通過,其效力與投票表決同;有異議者,應依前項規定採取投票方式表決。並於股東會召開後當日,將股東同意、反對及棄權之結果輸入公開資訊觀測站。

同一議案有修正案或替代案時,由主席併同原案定其表決之順序。如其中一案已 獲通過時,其他議案即視為否決,勿庸再行表決。

議案表決之監票及計票人員,由主席指定之,但監票人員應具有股東身分。計票 應於股東會場內公開為之,表決之結果,應當場報告,並作成紀錄。 第十三條 股東會有選舉董事時,應依本公司所訂相關選任規範辦理,並應當場宣 布選舉結果,包含當選董事名單與其當選權數及落選董事名單及其獲得之選舉權 數。

前項選舉事項之選舉票,應由監票員密封簽字後,妥善保管,並至少保存一年。但經股東依公司法第一百八十九條提起訴訟者,應保存至訴訟終結為止。

第十四條 股東會之議決事項,應作成議事錄,由主席簽名或蓋章,並於會後二十日內,將 議事錄分發各股東。議事錄之製作及分發,得以電子方式為之。

本公司前項議事錄之分發,得以輸入公開資訊觀測站之公告方式為之。

議事錄應確實依會議之年、月、日、場所、主席姓名、決議方法、議事經過之要 領及表決結果(包含統計之權數)記載之,有選舉董事時,應揭露每位候選人之 得票權數。在本公司存續期間,應永久保存。

前項決議方法,係經主席徵詢股東意見,股東對議案無異議者,應記載「經主席 徵詢全體出席股東無異議通過」;惟股東對議案有異議時,應載明採票決方式及 通過表決權數與權數比例。

第十五條 徵求人徵得之股數及受託代理人代理之股數,本公司應於股東會開會當日,依規 定格式編造之統計表,於股東會場內為明確之揭示。

股東會決議事項,如有屬法令規定、臺灣證券交易所股份有限公司(財團法人中華民國證券櫃檯買賣中心)規定之重大訊息者,本公司應於規定時間內,將內容傳輸至主管機關指定申報網站。

第十六條 辦理股東會之會務人員應佩戴識別證或臂章。

主席得指揮糾察員或保全人員協助維持會場秩序。

糾察員或保全人員在場協助維持秩序時,應佩戴「糾察員」字樣臂章或識別證。 會場備有擴音設備者,股東非以本公司配置之設備發言時,主席得制止之。

股東違反議事規則不服從主席糾正,妨礙會議之進行經制止不從者,得由主席指揮糾察員或保全人員請其離開會場。

第十七條 會議進行時,主席得酌定時間宣布休息,發生不可抗拒之情事時,主席得裁定暫時停止會議,並視情況宣布續行開會之時間。

股東會排定之議程於議事(含臨時動議)未終結前,開會之場地屆時未能繼續使用,得由股東會決議另覓場地繼續開會。

股東會得依公司法第一百八十二條之規定,決議在五日內延期或續行集會。

第十八條 本規則經股東會通過後施行,修正時亦同。

條所規定不得超過實收股本百分之四十之限制。

第 四 條: 本公司設總公司於基隆市,必要時經董事會之決議得在國內外設立分公

司。

第 五 條: 本公司之公告方式,依公司法第二十八條規定辦理。

第五條之一: 本公司得依證券管理法令之規定,辦理對外保證或提供財產設定擔保。

第五條之二: 本公司閒置資產之出租或處分或其他管理行為之事宜,由董事會全權處

理之。

第二章 股份

行之。本公司發行新股時得採免印製股票之股份登錄方式,應洽證券集中保管事業機構辦理,或得就每次發行總數合併印製,亦得依證券集中保管機構之請求,合併換發大面額證券,有關股票事務之處理,悉依公

開發行股票公司股務處理準則及其他有關法令規定辦理。

第八條: 股東名簿之記載變更,自股東常會開會前六十日內,股東臨時會開會前

三十日內或公司決定分派股息及紅利或其他利益之基準日前五日內,不

得為之。

第三章 股東會

第 九 條: 股東會分常會及臨時會二種,公司召開股東會時,得採行以書面或電子

方式行使其表決權,常會每年至少召集一次,於每會計年度終了後六個月內由董事會依法召開之,臨時會於必要時依法召集之。前項股東會除

公司法另有規定外,均由董事會召集之。

第 九 條之一: 本公司召開股東會得以視訊會議或其他經中央主管機關公告的方式舉

行。股東會開會時,如以視訊會議為之,其股東以視訊參與會議者,視

為親自出席。

採行視訊股東會應符合之條件、作業程序及其他應遵行事項等相關規

定,證券主管機關另有規定者從其規定。

第 十 條: 股東因故不能出席股東會時,得出具公司印發之委託書載明授權範圍,

簽名蓋章委託代理人出席,其代理出席之規範依照公司法第一七七條規

定辦理。

第十一條: 本公司股東除法令另有規定外,每股有一表決權。

**第十二條: 股東會之決議除公司法另有規定外,應有代表已發行股份總數過半數之** 

股東出席,以出席股東表決權過半數之同意行之。

第十二條之一: 本公司股東會之進行,依本公司股東會議事規則辦理之。

第十二條之二: 股東會之主席,除公司法另有規定者外,由董事長擔任之,因故需由他

人代理時,依公司法之規定辦理。

第十二條之三: 本公司撤銷(停止)公開發行股票需經股東會決議通過,始生效力。

第四章 董事

第十三條之一

第十三條: 本公司設董事七至九人,任期三年,由股東會就有行為能力之人選任之,

得連選連任。本公司上述董事名額中,獨立董事人數不得少於三人,且 不得少於董事席次五分之一。董事選舉採公司法第一百九十二條之一之 候選人提名制度。董事候選人提名之受理方式及公告等相關事宜,悉依

公司法、證券交易法相關法令規定辦理。

本公司依據證券交易法第十四條之四規定設置審計委員會,審計委員會

應由全體獨立董事組成,審計委員會負責執行公司法、證券交易法、及

其他法令規定監察人之職權,以及證券交易法規定審計委員會之職權。

第十四條: 董事會之決議,除公司法另有規定外,應有過半數董事之出席,出席董

事過半數之同意行之;董事會開會時,如以視訊會議為之,其董事以視

訊參與會議者,視為親自出席。

第十五條: 董事會由董事組織之,由三分之二以上董事之出席,及出席董事過半數

之同意,互推董事長及副董事長各一人,董事長對外代表公司。

第十六條: 董事長請假或因故不能行使職權時,其代理依公司法第二百零八條規定

辨理。

董事應親自出席董事會,董事因故不能出席者,應依法出具委託書列舉召集事由之授權範圍委託其他董事代理出席,前項代理以一人委託為限。

本公司之各項事務,除依法令、章程規定,應由股東會決議之事項外,

均得由董事會決議行之。

第十六條之一: 董事會召集時應載明事由,於七日前書面通知各董事,但遇有緊急情事

時,得隨時召集之。本公司董事會之召集得以書面、電子郵件(E-mail)

或傳真方式通知各董事。

第十七條 (刪除)

第十八條: 本公司董事之報酬,不論公司營業盈虧,公司支給報酬,其報酬授權董

事會依其對公司營運參予程度及貢獻之價值,參酌同業通常之水準議定

之。如公司有盈餘時,另依第二十一條之規定分配酬勞。

第十八條之一: 本公司得於董事任期內就其執行業務範圍依法應負之賠償責任為其購買 責任保險,以降低並分散董事因違法行為而造成公司及股東重大損害之

風險。

第五章 經理人

第十九條: 本公司得設置經理人,其委任、解任及報酬,依照公司法第二十九條規

定辨理。

經理人為公司管理事務及簽名之權限存否及其範圍,由董事會另訂之。

第六章 會計

第二十條: 本公司應於每屆會計年度終了,由審計委員會同意並送董事會決議(一)

財務報表,並由董事會造具(二)營業報告書(三)盈餘分派或虧損撥補之議案等表冊,於股東常會開會三十日前送交審計委員會查核後,由審計委員會出具上開(一)財務報表(二)營業報告書(三)盈餘分派或虧損撥補之議案等各項表冊之編製及查核報告,提交股東常會,請求

承認。

第二十一條: 公司年度如有獲利 (所謂獲利係指稅前利益扣除分派員工酬勞及董事酬

勞前之利益),應提撥不低於百分之八為員工酬勞及不高於百分之三為董事酬勞。但公司尚有累積虧損(包括調整未分配盈餘金額)時,應預

先保留彌補數額。

前項員工酬勞得以股票或現金為之,其發給對象得包括符合董事會所訂

條件之從屬公司員工。前項董事酬勞僅得以現金為之。

前二項應由董事會決議行之,並報告股東會。

本公司審計委員會設置前,監察人酬勞倂同董事酬勞,以年度獲利之不

第二十一條之一: 高於百分之三分派,並準用本條之規定。

公司年度總決算如有本期稅後淨利,應先彌補累積虧損(包括調整未分配盈餘金額),依法提撥10%為法定盈餘公積;但法定盈餘公積累積已達本公司實收資本總額時,不在此限。次依法令或主管機關規定提撥或迴轉特別盈餘公積。嗣餘盈餘,連同期初未分配盈餘(包括調整未分配盈餘金額),由董事會擬具盈餘分配議案,授權董事會以三分之二以上董事之出席,及出席董事過半數之決議,將應分派股息及紅利或公司法第二百四十一條第一項規定之法定盈餘公積及資本公積之全部或一部,以發放現金之方式為之,並報告股東會;其以股票股利發放部分則需提請股東會決議分派。

本公司股利政策,係配合目前及未來之發展計畫、考量投資環境、資金 需求及國內外競爭狀況,並兼顧股東利益等因素,每年就可供分配盈餘 提撥不低於百分之十分配股東股息紅利,惟累積可供分配盈餘低於實收 資本百分之十時,得不予分配;分配股東股息紅利時,得以現金或股票

方式為之,其中現金股利不低於股利總額之百分之十。
